**Series II: CRG 1, College of Law General and Administrative**

**Historical Note:** In 1970 the College faculty authorized the Dean to proceed with the creation of a Board of Visitors. Members of the Board meet annually at the College to provide the Dean, and indirectly the faculty, a sounding board for the College's operations and plans. As of 2012 the Board had two subcommittees which focused on the College's curriculum and development efforts. The annual meeting included an "Academic Summit" to explore methods to improve legal education and ease students' transition from student to lawyer.

Until 1929 the law program had no building of its own. Classes, faculty, and library were accommodated from time to time as needed by Agriculture, the Library, Old Main, and Herring Hall, on a space available basis. On October 29, 1929, the College occupied the remodeled former University Library building. A wing was added in 1948 for book stacks. In later years this handsome building was designated the Douglass Building. On January 4, 1961, the College moved into new quarters on the south side of campus. This was the first building designed and constructed solely as a law college facility. Severe space problems in the 1970s nevertheless encouraged a campaign for a yet larger building. Eventually this second, semi-permanent home was renamed the Franklin Building and converted to use by the Journalism Department after the College of Law moved in May 1979 to the north side of campus to property fronting Speedway Avenue at Mountain.

The new Speedway building was formally dedicated September 8, 1979. Renovations of varying extent occurred in---, 1996 and 2007. On April 18, 1997, the building complex was dedicated as the James E. Rogers Law Center. On November 20, 1998, the Board of Regents approved naming the College the James E. Rogers College of Law in gratitude to Mr. Rogers' generous financial support. With the renaming of the College itself as the James E. Rogers College of Law, the physical facilities became again the College of Law building.

In 1999, with funds from alums George Rountree and James E. Rogers, the College purchased the neighboring Chi Omega sorority building facing Mountain Avenue. It was initially named Rogers-Rountree Hall, but later came to be called simply Rountree Hall, in honor of donor George Rountree and following a renaming dedication September 13, 2005. This Southern colonial style building housed clinical and other programs.

In 2007 an extensive renovation and remodeling reconfigured the main building, particularly opening facilities to natural light.

**Scope and Contents:** This series contains material related to the college of law in its broadest sense including administrative correspondence, the colleges COVID-19 response, ephemera or correspondence related to college specific events, governing documents, and strategic plans.

Historical Notes: Catalog listings for a named entity dealing with finance begin with 1976-77. Janie A. Hossfield (later Janie A. Nunez) was listed as Assistant to the Dean from 1976-77 through 1979-80). Over time titles change and record the formation of a separate department. The 1980-81 Catalog lists Henrietta Stover as Assistant to the Dean. Between the years represented by the Catalog 1986-88 through 1989-91, Henrietta Stover was identified as Financial Manager. The 1991-94 Catalog gives her title as Director of Financial Services. With the 1994-97 Catalog the title became Assistant Dean for Finance and Administration. Approximately from the arrival of Henrietta Stover, Cissi Armstrong served as bookkeeper. She retired on January 6, 2012. On September 6, 2011, Jeffrey M. Ratje assumed the position of Director of Finance (reporting to Sally Rider). On June 13, 2012, Dean Ponoroff announced that Ratje would assume the position of Assistant Dean, Finance and Administration as part of a restructuring in which Leudell ripp became responsible for personnel, audit, accounting, and LCA work.

When Ratje left in 2013 for the College of Agriculture, Kelly Moyes was hired as Director of Finance and Administration.

**Series III: CRG 2, College of Law Deans, 1915-Present**

**Historical Note:** In 1915 a Department of Law was created as part of the College of Letters, Arts and Sciences. Accepting students in Fall 1915, it had a faculty of three: Sidney J. Frank served as Head, with two colleagues, Howard M. Colvin and Samuel M. Fegtly (who succeeded Frank in the position of Head). For the Department of Law, 1915 through summer 1919, and as the School of Law, 1919 through 1925, the formal title for director was "Head." In 1925 the new-designated College of Law was appropriately headed by a "Dean."

Early deans had administrative assistance, and a simple administrative structure served operational needs for many years. Names, associated titles and dates, are not always clear.

Beginning with (at least) the 1947-1949 Catalog the positions of Secretary and Stenographer were listed in the printed volumes. Between 1947 and 1951, H. Frances Hardy filled the position of Secretary; Joanne Kime, Stenographer. Between 1951 and 1953, Ruth A. Stanger held the position of Secretary; Anne Mackin also was listed as Secretary. From 1953 through 1967, Anne Mackin was listed as Secretary with two brief notings of a stenographer: Rose Cracchiolo (1955-1957), Marilyn B. Stewart (1957- 1959).

Rhoda Keppel provided administrative assistance to Deans Ares and Livermore, with unstable titles. Between 1976-1977 administrative assistance was given by two persons identified as "Assistant to the Dean": Janie L. Hossfeld and Seva Jaffe Kramer. Kramer replaced Keppel. An Arizona Advocate article for September 1977 characterizes Hossfeld as "a veteran of the previous administration and [who] supplied needed expertise and continuity. Reportedly the only person who understands the law school budget, she also specializes in problems of admission." See CRG 5. In 1976 Helen Marshall was identified as Secretary to the Dean/Placement Director.

Higher level assistance was formally noted in Catalogs: in 1967-1968 and 1969-1971 John J. Irwin, Jr. held the titles of Assistant Dean and Professor of Law. The 1971-1973 Catalog recorded Arthur Andrews as Associate Dean and Professor of Law, while Daniel H. O'Connell was Assistant Dean and Professor of Law. During 1973-1975 Arthur Andrews was again listed as Associate Dean and Professor of Law; John M. Greacen, Assistant Dean and Assistant Professor of Law. The Catalogs gave no listings in these positions from 1975 to 1978. Mike Sacken held the title Associate Dean from 1978 into 1982, and, according to a statement in the Arizona Advocate, September 1977, understood "his primary role as strengthening placement and counseling services." He was succeeded by Armando Rivera.

Ultimately these "associate" and "assistant" dean positions evolved into formal offices as, for example, an Associate Dean for Academic Affairs, who handles curriculum and class scheduling. Papers of these entities are filed under individual categories below, separate from the Dean.

### Series VIII: CRG 7, Admissions and Financial Aid

**Historical Note:** The functions of admissions to the College and the awarding of financial aid have generally become increasingly formalized. In earliest years these essential activities appear to have been carried out within the College in a simple set of steps under the direct control of the Dean and faculty. By at least 1947-49 "students applying to the College of Law must present to the Dean of the College a certificate of the University Registrar certifying that the applicant has completed all "prelegal" requirements. Applications at that time went to the Dean. Applications for special students or for advanced standing were approved by the faculty.

By 1955-57 the LSAT (Law School Admission Test from the Educational Testing Service, or ETS, Princeton, New Jersey) was required. Admissions were based on forms which were obtained through the University Director of Admissions. By 1967-69 the Catalog stated: "First-year students are admitted only in the fall semester. Inquiries should be directed to the Assistant Dean's office in the fall term prior to the year in which admission is sought." The Assistant Dean at that time was John J. Irwin. In subsequent years inquiries were to be directed to a specific place, the "College of Law (Room 405)" of the now-demolished College of Law building later known as the Franklin Building. In 1971-73 the Assistant Dean was Daniel H. O'Connell, followed in the 1973-75 Catalog by John M. Greacen. An Executive Committee of the College of Law is listed, having oversight of, at least, seniors from other colleges taking Law courses. The Law College handled its own student loans and scholarships, but the University as a whole could also award loans or scholarships to law students through its Office of Scholarships & Financial Aid. In 1971-73 loans were not available through Law, but through the University Student Aid Office.

A major addition to admission requirements by 1973-75 was an applicant's completion of a "Law School Data Assembly Service Report" or LSDASR, filed with ETS in Princeton, New Jersey, which effectively mandated uniform information for each applicant.



By 1977-78 the Catalog mentions an Admissions Office, not simply Room 405, and an Admissions Committee. Mary Delgado served in Admissions from 1979-1982. In 1982 Armando Rivera served as Associate Dean from 1982. In 1985 Terry Sue Holpert and Amy Shiner job-shared as Assistant Dean for Student Affairs. Terry Holpert remained with the College as, in a changed role, Assistant Dean for Admissions. She retired in December 2008 and was succeeded by Assistant Dean Eric Eden (Jan. 2009 to June 2012). Allison J. Nash served first as Assistant Director of Admissions under Eden. After November 2010 she was promoted to Director of Admissions and Financial Aid (Kirn Marlow, then financial aid counselor departed "precipitously"). Katherine E. Grounds became Assistant Director of Admissions in November 2010. On December 10, 2012 she was succeeded by Bianca Mack as Director of Admissions and Financial Aid.

**Series IX: CRG 8, Student Affairs**

**Historical Note:** Serving a total of eight years in various capacities at the Law School Rhoda Keppel rose from the position of Dean Charles Ares' secretary, Administrative Assistant, then Assistant to the Dean, and finally as the first woman to hold a deanship as Assistant Dean. She worked heavily with students. Between 1972 and 1973 John Greacen served as Assistant Dean, overseeing admissions, financial aid and registration. Rhoda Keppel assumed his work as Assistant to the Dean (named to this position by new

Dean Roger Henderson). She left this position in Jan. 1976. In 1990 Dr. Willie M.J. Curtis became Assistant Dean of Student Affairs (a position held alone by Assistant Dean Terry Holpert since 1989).
